### Awards and Regulations:

Six ribbons will be awarded in all classes. A Champion and Reserve ribbon and prize will be awarded in each division. All exhibitors must wear ASTM/SEI approved headgear at all times when mounted on the show grounds. A horse or pony must have been entered, and completed at least one jumping class in a division in order to be eligible for the under saddle class. A negative Coggins test is required of all animals on the grounds. This show is run in accordance with the current ground rules of the VHSA with the exception of fence height.

We reserve the right to refuse any entry, to change the time schedule, to combine classes, or change Judges at any time. There will be no posted jump order with the exception of Equitation classes. The one-minute rule for entering the ring will be enforced. Horse Show Management and its staff will not be responsible for accidents or loss of property.

All juniors must have an adult oversee schooling. At management's discretion, any exhibitor deemed unsafe or not in control may be asked to leave the ring or schooling area.

## **Friday Schooling**

Weather permitting, supervised schooling will be allowed Friday, July 24, 2020 from 12:00 p.m. to 5:30 p.m. at a cost of \$25.00 per horse.

## **California Warm-Up**

Each horse and rider combination may participate in one warm-up class. At management's discretion, this class may be discontinued at any time. You must let the starter know before you enter the ring if you are participating in the warm-up. You must jump Course B or the posted warm-up course.

### **COVID-19 Warning**

We have taken enhanced health and safety measures for you, our other exhibitors, and staff. You must follow all posted instructions while on these show grounds.

An inherent risk of exposure to COVID-19 exists in any public place where people are present. COVID-19 is an extremely contagious disease that can lead to severe illness and death. According to the Centers for Disease Control and Prevention, senior citizens and guests with underlying medical conditions are especially vulnerable.

By visiting this CP/MP Horse Show, you voluntarily assume all risks related to exposure to COVID-19.

### **COVID-19 Safety Measures**

- Only show staff, trainers, riders, guardians of minors, and essential support personnel may attend the show. We ask that you limit the number of essential staff and family members to the greatest degree possible.
- If you are having any symptoms of illness such as headache, stomach-ache, coughing, excessive sneezing, runny nose, aches, or are generally not feeling well, please stay home.
- Anyone currently exhibiting COVID-19 symptoms, who has tested positive or has been in contact with someone who has tested positive for COVID-19 in the 14 days prior to arriving at the grounds should not attend the event.
- Hand sanitizer will be at both rings and schooling rings. Gloves are recommended.
- Individuals are encouraged to bring their own sanitizing products for personal use.
- Social distancing of 6 feet apart should be observed everywhere on the show grounds.
- In the event of inclement weather, exhibitors should shelter in their vehicles. Do not crowd the stable area.
