# TURNER FARM RULES AND REGULATIONS

**Office Fee:** A \$20.00 Office Fee will be charged per rider.

**Class Specifications:** Every class labeled VHSA will be conducted and judged according to the current VHSA Rule Book. The Judge's decisions are always final.

**Cross Entering:** Leadline may enter Pre-Short Walk, Pre-Short rider may not canter or jump. and Short Stirrup may not jump over 18"

**Entries: NO POST ENTRIES ACCEPTED! ENTRIES WILL CLOSE 48hrs prior to each show date.** Management has the right to limit the number of entries at the show to comply with state, county and park capacity restrictions. ENTRIES CAN CLOSE EARLY!  
No office fee refunds if you scratch after the closing dae. No more then one person at a time at the secretary stand when picking up numbers. Check-out will be online only and credit cards will be charged at the end of each show for any unsettled invoices.

**Coggins Test:** Prior to the show, all exhibitors must submit an electronic copy of a Negative Coggins Test taken within one year on each animal exhibited.

**Entry Fees:** \$20.00 per class.

**Schooling:** Schooling permitted in show ring from 6:30 am -7:30 am. Additional schooling breaks will be offered if time allows. Open card warm-ups will be available if time allows.

**Responsibilities:** Horse show staff, volunteers, Turner Farm Events, Turner Farm Park and Fairfax County Park Service, their officials and employees will not be responsible for any accident, or loss, which may occur to any exhibitor, spectator, rider, guest, groom attendant, or other employee, animal or equipment at the show. The show reserves the right to decline or accept any entry and return any entry fees before or during the show without being liable for compensation; to change the location, combine, cancel, split or limit any classes; or change any officials.

**Dogs:** All Dogs must be on leashes while on the show grounds.

**Awards:** Six ribbons per class. Points scored as follow:

3 to 5 exhibitors-10, 6, 4, 2, 1, .5; 6 to 9 exhibitors- 11, 7, 5, 3, 2, 1.5; 10 or higher- 12, 8, 6, 4, 3, 2.5

EVERYONE ENTERING TURNER FARM PROPERTY WILL BE CHECKED IN UPON ARRIVAL  
YOU WILL BE REQUIRED TO SIGN A WAIVER AND WILL BE GIVEN A WRISTBAND.

## DIVISION & CLASSES

### **Schooling Hunter**

Open to horses and ponies judged on performance, manners, way of going, suitability and soundness. Fences 2'6"

### **VHSA Children's/Adult Amateur Hunter**

Open to Juniors and Adult Amateur riders on horses. Fences 2'6", 3'

### **VHSA Working Hunter**

Open to horses and to ponies. Ponies may not be entered in pony divisions at same show. Fences 3'

### **Low Hunter**

Open to horses and ponies judged on performance, manners, way of going, suitability and soundness. Fences 2'

### **VHSA Pony Hunter**

Open to ponies 14.2 and under ridden by Juniors. Small 2', Medium 2'3", Large 2'6"

### **VHSA Pony Pleasure**

Open to Ponies 14.2 hands & under in hunter tack to be ridden by junior riders only. To be judged on manners, suitability, soundness, way of going.

### **VHSA Horse Pleasure**

Open to horses in hunter tack ridden by juniors and adults. To be judged on manners, suitability, soundness, way of going.

### **Lead Line**

Open to riders 7 and under to be led at the walk. Rider not eligible for any other classes that they would be asked to trot. To be judged on rider's equitation and pony's suitability and manners as a leadline mount.

### **Pre-Short Stirrup**

Open to riders 10 & under. Riders may be asked to walk, trot & perform simple equitation test. May not cross enter into classes where asked to canter or jump.

### **Long Stirrup**

Open to riders 13 years and over. Fences at 18". Horses and riders may only cross enter into Pleasure & non-VHSA classes

### **Short Stirrup Equitation**

Open to riders 12 & under. Fences at 18". May not enter any classes with fences over 18".

### **VHSA Short Stirrup**

Open to riders 12 years and under. May not jump higher than 2' at this show. Horses and riders may only cross enter into Pleasure & non-VHSA classes



## DIRECTIONS & PARKING

Turner Farm is located at the intersection of Georgetown Pike (Route 193) and Springvale Road (Route 674) in Great Falls, Virginia (the horse show entrance is on Springvale Road )

Trailer parking is on the grass to the left as you pull into the property.
