Div. \$40 ea., Class & Warmup \$20 each
- **Day of Show:** Div. \$50 ea., Class & Warmup \$25 each
- **Stall:** \$35 a day. Additional \$35 for each overnight.
- Checks payable to **ECETC**. Return check fee: \$35.
- Open checks are permitted for day of show.
- **Current Negative Coggins** must be left with show secretary
- Show held in accordance with ECHSA & VHSA Assoc. Prog.

- The Judge's decision is final.
- ASTM/SEI helmets must be worn by all riders when mounted.
- Management reserves the right to combine, split or cancel any class or division it deems necessary.
- Six ribbons will be awarded to the top 6 placed competitors. Championship and Reserve in each division.
- Dogs are **not** permitted on ECETC show grounds.
- Signature on entry form indicates riders, trainers and owners accept the condition of entry as outlined on the entry form.
- **Parking:** Trailers: in field to right of indoor arena. Parking in front of facility is reserved for judges, ECETC owners, staff and boarders

Conditions of Entry: Participants realize and accept the inherent risks, injuries & death due to equine activities. Every horse entered for competition will be under the control of the Show Management but Management will in no case be responsible for any loss or damage that may occur, and it shall be a condition of entry that each exhibitor shall hold the Show, Management, and the facility harmless for any loss or accident to his or her horse, horses, or equipment which may occur from sickness, fire or otherwise. Management reserves the right to interpret all questions and conditions regarding or arising out of an incident at the show without claims for damages or recourse of any kind. All questions not covered in these rules and regulations shall be decided by Management, and their decision is final. Discourtesy to an official or show staff by any spectator, rider, trainer, or groom will disqualify the horse or horses with which they are associated, and all fees will be forfeited.

Covid-19 Precautions

- Online entries are required.
- There will be no concessions provided. Please bring your own.
- Stalls will be assigned by show management with extra space between barn/trainer groups. We will notify you of your stall placement prior to show. Stalls will be limited.
- Trainers may pick up show packets with rider show numbers and jump course at secretary stand day of show. Trainers must provide a copy of their participating exhibitors' valid Coggins and entry fees when picking up show packet.
- Warm up ring will be open 30 minutes prior to the show. Please limit the warmup ring to no more than 6 horses at a time. There are plenty of open grass areas if you need to lunge or ride your horse before your time in the warmup ring is open.
- Trainers should stay on track with schooling and getting your students to the rings. Please make the gate keepers aware of any problems or conflicts. It is essential to keep the day moving as there are extra warm-up sessions throughout the day.
- Class results will be announced, and ribbons may be picked up at the ribbon rack.
- Social distancing must always be a priority . This includes the secretary stand, gatekeepers, and announcers. Non-related groups standing or sitting need to keep at least 6 feet apart and no gatherings of more than 50 people in a given area.
- Spectators are not allowed. Parents may accompany minor exhibitors but please limit to one parent if possible.
- There is plenty of space on the show grounds when parking please keep a minimum of 12' between all vehicles.
- Masks are required while on show grounds except while mounted.
- It is strongly suggested you bring your own hand sanitizer.
- Bathrooms will be stocked with disinfectant spray. It is up to each user to clean surfaces prior to and after use.
- Exhibitors should leave the premises 30 minutes after their classes are completed!
