Schooling: Friday, 11:00am to 5:30 p.m., weather permitting, \$30 per horse payable Friday.

Schooling will be free beginning at 6:30 a.m. Saturday morning, but the number allowed in the ring at a given time may be limited. Short stirrup riders will have a ten-minute session prior to their first class.

Stalls: \$45, no bedding, reserve in advance on your pre-entry. **Cancel by noon on Thursday, September 12 to avoid being charged.**

This is a member show of the Capital Horse Shows Association and a VHSA Associate Show. The show will be run in accordance with VHSA rules except for fence heights. Six ribbons will be awarded in all classes. A Champion ribbon and award and a Reserve ribbon will be awarded in all year end award divisions. A horse or pony must have shown in at least one class over fences to be eligible for the under saddle class of that division. Equitation classes may have a posted order.

Exhibitors must wear ASTM/SEI approved, protective headgear at all times when mounted. Junior riders must always be supervised by an adult. All owners and riders must sign a waiver of liability stating that neither the Deep Run Hunt Club, nor the Deep Run Hunt Horse Show Association, nor the VHSA or CHSA will be responsible for any accidents. An adult must sign for all junior riders.

Dogs must always be leashed. All motorized vehicles must be operated by a licensed driver.

The show committee reserves the right to refuse entry, to change the schedule, to combine classes, and to change judges at any time. **Pre-entries must be signed in all applicable places, received by Tuesday, September 10, and include a legible copy of the Coggins. A current, negative Coggins report is required of all horses and ponies on the grounds.**

ENTRIES CLOSE September 10, 2024 - IF TIME PERMITS, POST ENTRIES WILL BE ACCEPTED, WITH A \$15.00 POST ENTRY FEE THROUGH FRIDAY, September 13, 2024.

AGREEMENT

RELEASE, ASSUMPTION OF RISK – WAIVER AND INDEMNIFICATION. This document waives important legal rights. Read it carefully before signing. This agreement is given in part under the Virginia Equine Activity Liability Act (Section 3.2- 6200 et seq. of the Code of Virginia, 1950, as amended), which as it may now provide or be hereafter amended. Schooling and/or entry constitutes an express agreement and affirmation that the owner, rider and any of their agents or representatives acknowledge that they participate voluntarily in the competition, fully aware that horse sports involve intrinsic dangers and risk of serious injury or death, and by participation they expressly assume any and all risk of injury or loss, and agree to indemnify the Deep Run Hunt Club, Inc., the Deep Runt Hunt Horse Show Association, the VHSA and CHSA, their agents, assigns, and employees harmless from and against any and all claims, including for injury or loss suffered during the competition, whether or not such claim, injury, or loss resulted, directly or indirectly, from negligent acts or omissions of said agents, assigns, or employees.

TO BE SIGNED BY ADULT PARTICIPANTS, PARENTS/GUARDIANS OF PARTICIPANTS UNDER THE AGE OF 18 (“MINOR”) OR DULY AUTHORIZED REPRESENTATIVES, all as more particularly described in Section 3.2-6202 of the Code of Virginia, 1950, as amended, OF PARENTS/GUARDIANS OF MINORS (“REPRESENTATIVE”). BY SIGNING THIS AGREEMENT, I CONSENT TO THE MINOR’S PARTICIPATION AND AGREE TO ALL OF THE ABOVE PROVISIONS AND ACKNOWLEDGE THAT I AM AWARE OF THE HELMET RULE FOR JUNIOR EXHIBITORS.
