Note: Application, fees, show prize list and Insurance Certificate are to be received in the VHSA office 30 days prior to competition date. Prize list should indicate that the show is VHSA Associate Competition Member. Show results must be in the VHSA office within fourteen (14) days of the competition, including any VHSA Membership/Horse Recording Applications. If not received within the allotted time, a \$100 fine will be imposed and possibility of future shows having their "VHSA Associate" recognition canceled. Any Judge officiating at a VHSA Associate recognized show must be from the VHSA Associate Approved Judge's List and a current VHSA Member, or a special exception request submitted to the VHSA office 2 weeks prior to show date for approval by the Associate Executive Committee.
